PURPOSE

WHAT ARE PARENTAL RIGHTS?



Parental rights refer to the legal rights and responsibilities that parents have in relation to their children. These rights and responsibilities encompass various aspects of a child's life and upbringing and over the past **several years some of the most important aspects have been grossly infringed upon** including, but not limited to:

Decision-Making: The authority to make decisions on behalf of the child, including decisions related to education, medical treatment, and other important matters.

Consent: The ability to give or withhold consent for various activities involving the child, such as medical treatment, participation in extracurricular activities, and travel.

Protection and Care: The responsibility to provide a safe and nurturing environment for the child's physical and emotional well-being.

Access to Records: The right to access the child's educational, medical, and other records as necessary for the child's well-being and development.

WHAT THE CONSTITUTION SAYS ABOUT PARENTAL RIGHTS

In a [brief Amicus Curiae](#) submitted to the Supreme Court of North Carolina by The Justice Foundation, a history of U.S. Supreme Court rulings related to the definition and protection of parental rights is outlined.

Nearly one hundred years ago, this Court acknowledged that “the child is not the mere creature of the State; those who nurture him and direct his destiny have the right, coupled with the high duty, to recognize and prepare him for additional obligations.” *Pierce v. Society of Sisters*, 268 U.S. 510.

That same year, in *Wisconsin v. Yoder*, 406 U.S. 205, the Court declared that “[t]his primary role of the parents in the upbringing of their children is now established beyond debate as an enduring American tradition.” *Id.* at 232.

And in *Troxel v. Granville*, 530 U.S. 57, 5 this Court again unequivocally affirmed the fundamental right of parents to direct the care, custody, and control of their children.

Thereafter, in *Stanley v. Illinois*, 405 U.S. 645, this Court affirmed the fundamental rights of parents “in the companionship, care, custody, and management” of their children. *Id.* at 651.

More recently, this Court declared in *Washington v. Glucksberg*, 521 U.S. 702, that the Constitution, and specifically the Due Process Clause of the Fourteenth Amendment, protects the fundamental right of parents to direct the care, upbringing, and education of their children. *Id.* at 720.

Quoting *Yoder* and *Troxel* in response to a public school district’s subjection of children to inappropriate and sexually explicit content, the United States House of Representatives affirmed that “Yet today, State courts of last resort throughout the United States are split, adjudicating children as “creatures of the State” by limiting or terminating parents’ rights through using a subjective “best interest of the child” the fundamental right of parents to direct the education of their children is firmly grounded in the Nation’s Constitution and traditions.” House Resolution 547.

The Justice Foundation summarizes its position in this regard: We believe in protecting children from those who would destroy their innocence and exploit them for their own purposes. On the whole, parents are the best protectors of children and have the natural right and duty for the care, custody, and control for their children. Children, in the main, are naturally incapable of exercising self-government until reaching the age of majority.

PARENTAL RIGHTS

ARE NATURAL RIGHTS!



As autonomous human beings, this should not be up for debate.

Natural rights, also known as human rights or inalienable rights, are fundamental rights and freedoms considered inherent to all human beings by virtue of their humanity. These rights are often seen as universal, inalienable, and not contingent upon the laws, customs, or beliefs of any particular society, government, or culture. Natural rights are often considered the foundation of ethical and legal principles, serving as a basis for the development of legal and political systems.

The concept of natural rights is rooted in the idea that individuals possess certain fundamental entitlements simply because they are human, **and these rights should be respected and protected by society and government.**

When the authors of the U.S. Declaration of Independence spoke of all people being endowed with “unalienable Rights,” such as “Life, Liberty and the pursuit of Happiness,” they were confirming their belief in the existence of “natural rights.” In modern society, every individual has two types of rights: natural rights and legal rights.

- **Natural rights** are rights granted to all people by nature or God that cannot be denied or restricted by any government or individual. Natural rights are often said to be granted to people by “natural law.”
- **Legal rights** are rights granted by governments or legal systems. As such, they can also be modified, restricted or repealed. In the United States, legal rights are granted by the legislative bodies of the federal, state and local governments.

DID YOU KNOW

FACTS, DATA & TALKING POINTS



According to the **NIH**, **mental illnesses may begin to appear during adolescence.**

- Ongoing changes in the brain, along with physical, emotional, and social changes, can make teens more likely to experience mental health problems. The fact that all these changes happen at one time may explain why many mental illnesses—such as schizophrenia, anxiety, depression, bipolar disorder, and eating disorders—emerge during adolescence.

According to the **NIH**, **teen brains may respond differently to stress.**

- Because the teen brain is still developing, teens may respond to stress differently than adults. This could increase teens' chances of developing stress-related mental illnesses such as anxiety and depression. Recognizing possible triggers and practicing effective coping techniques can help teens deal with stress. Learn more about managing stress.

Adolescent brains are not fully formed, cannot make or consent to medical decisions, states The National Institute of Mental Health (NIMH), part of the National Institutes for Health (NIH)

According to the **NIH**, **adolescence is an important time for brain development.**

- The brain finishes developing and maturing in the mid-to-late 20s. The part of the brain behind the forehead, called the prefrontal cortex, is one of the last parts to mature. This area is responsible for skills like planning, prioritizing, and making good decisions.

According to the **NIH**, **brain development is related to social experiences during adolescence.**

- Changes to the areas of the brain responsible for social processes can lead teens to focus more on peer relationships and social experiences. The emphasis on peer relationships, along with ongoing prefrontal cortex development, might lead teens to take more risks because the social benefits outweigh the possible consequences of a decision.

According to the **NIH's** National Library of Medicine, **Children** (typically under 17) **cannot provide informed consent.**

- As such, parents must permit treatments or interventions. In this case, it is not termed "informed consent" but "informed permission."

FACTS, DATA & TALKING POINTS



According to the **CDC**, **experiencing child sexual abuse can affect how a person thinks, acts, and feels over a lifetime**. This can result in short- and long-term physical, mental, and behavioral health consequences.

What are the consequences?

Examples of physical health consequences include:

- sexually transmitted infections (STIs)
- physical injuries
- chronic conditions later in life, such as heart disease, obesity, and cancer

Examples of mental health consequences include:

- depression
- posttraumatic stress disorder (PTSD) symptoms

Examples of behavioral consequences include:

- substance use/misuse, including opioid misuse
- risky sexual behaviors, meaning sex with multiple partners or behaviors that could result in pregnancy or STIs
- increased risk for perpetration of sexual violence
- increased risk for suicide or suicide attempts

Drag Shows for Minors is Child Sexual Abuse, as defined by the Centers for Disease Control (CDC)

According to the **CDC**, **child sexual abuse refers to the involvement of a child** (person less than 18 years old) **in sexual activity** that violates the laws or social taboos of society and that he/she:

- does not fully comprehend
- does not consent to or is unable to give informed consent to, or
- is not developmentally prepared for and cannot give consent to

According to the **CDC**, **experiencing child sexual abuse can increase a person's risk for future victimization**. For example, recent studies have found:

- Females exposed to child sexual abuse are at 2-13 times increased risk of sexual violence victimization in adulthood
- People who experienced child sexual abuse are at twice the risk for non-sexual intimate partner violence

CONSIDERATIONS REGARDING CONSENT IN VACCINATING CHILDREN AND ADOLESCENTS BETWEEN 6 AND 17 YEARS OLD

Around the world, immunization programs are increasingly including, in their national immunization schedules, vaccines that target age groups beyond infancy and early childhood. This document is aimed at program managers who are planning to introduce vaccines for older children and adolescents aged between 6 and 17 years.

It provides information that should be considered when preparing guidance notes on the consent process, or for clarifying questions from the health workers who provide the vaccinations. The document is all the more important because this population group may present for vaccination without an accompanying parent or legal guardian.

THE PRINCIPLES OF CONSENT AND ASSENT

CONSENT

Consent is the principle wherein individuals must give their permission before receiving a medical intervention or procedure. According to the laws and regulations in place in most countries, consent is required for a range of medical interventions or procedures, from a simple blood test to organ donation, and including vaccinations. In only very few, well-described circumstances, such as life-threatening emergencies, may consent be waived. Consent derives from the principle of autonomy and forms an important part of medical and public-health ethics, as well as international law. For consent to be valid, it must be informed, understood and voluntary, and the person consenting must have the capacity to make the decision.

LEGAL AGE OF CONSENT

In most country's legal systems, the legal age of consent tends to coincide with the age of majority. This is 18 years in most countries. It follows, therefore, that a child or adolescent in the age group 6 to 17 years cannot provide consent to vaccination and so consent is normally required from their parent or legal guardian. In a growing number of countries, the age of consent for medical interventions is set below the age of majority.

ASSENT

Assent refers to the process of children's and adolescents' participation in the decision-making on vaccination (or other medical interventions). Assent is not regulated in law like consent, and is sometimes referred to as a moral obligation closely linked to good practice in dealing with patients. International law provides strong support for children's rights to participate in decisions about their health and health care, and also in the planning and provision of health services relevant to them and based on their evolving capacity



COVID-19 VACCINE DID YOU KNOW

Sharing vaccine and medical records is a HIPAA violation, per the CDC

(HIPAA) is a federal law that requires the creation of national standards to protect sensitive patient health information from being disclosed without the patient's consent or knowledge.

Health care providers have legal obligation to give informed consent, per NIH

According to the NIH, **Informed consent is the process in which a health care provider educates a patient about the risks, benefits, and alternatives** of a given procedure or intervention.

Informed consent is both an ethical and legal obligation of medical practitioners in the US and originates from the patient's right to direct what happens to their body.

LOCAL SOVEREIGNTY & THE CONSTITUTION



United States Constitution's Tenth Amendment says:

The powers not delegated to the United States by the Constitution, nor prohibited by it to the States, are reserved to the States respectively, or to the people.

The **Declaration of Independence** provides a foundation for the concept of popular sovereignty, the idea that the government exists to serve the people, who elect representatives to express their will.

State Constitutions like Montana's go as far to define **Popular Sovereignty** as:

All political power is vested in and derived from the people. All government of right originates with the people, is founded upon their will only, and is instituted solely for the good of the whole.



WHAT IS LOCAL SOVEREIGNTY & WHY IT MATTERS CONTINUED



- **Experimentation and Innovation:** Counties serve as laboratories for policy experimentation. Local governments can try out new approaches and innovative solutions to local problems, which can later inform state and national policy decisions if successful.
- **Cultural and Social Values:** Different regions within a country may have varying cultural, social, and political values. Local sovereignty allows counties to enact policies and regulations that align with the values and beliefs of their residents, promoting cultural diversity and pluralism within a nation.
- **Fiscal Responsibility:** County-level governments are often responsible for managing budgets and fiscal matters. This local accountability can help ensure that tax dollars are spent efficiently and in ways that benefit the community.
- **Disaster Response:** Counties are typically at the forefront of disaster response and emergency management. Local sovereignty ensures that counties have the authority and resources to respond rapidly to emergencies and natural disasters.
- **Preservation of Local Identity:** Counties can play a role in preserving and promoting local history, culture, and heritage. They may have the authority to protect historical landmarks and traditions that are important to their residents.
- **Balancing Centralization:** In federal systems of government, such as that of the United States, local sovereignty at the county level acts as a counterbalance to centralized state and federal authorities, preventing an excessive concentration of power and ensuring that government remains accountable and responsive to the people.

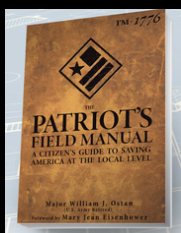
MAKING A DIFFERENCE ON A LOCAL LEVEL

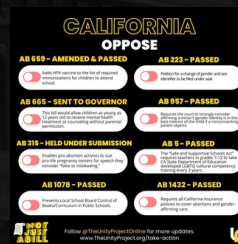

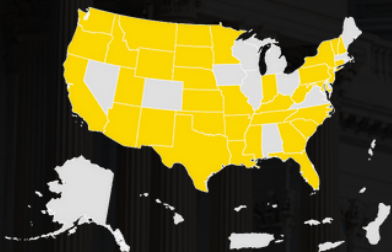
